Item 2 (Experimental medication)

As at 14 July 2021, according to the MHRA, 1490 people were reported to have died as a result of an adverse reaction to being injected with experimental COVID medication. Evidence from Scotland, US and Europe is similarly damning.

Article 6 – Consent

1. Any preventive, diagnostic and therapeutic medical intervention is only to be carried out with the prior, free and informed consent of the person concerned, based on adequate information. The consent should, where appropriate, be express and may be withdrawn by the person concerned at any time and for any reason without disadvantage or prejudice.
2. Scientific research should only be carried out with the prior, free, express and informed consent of the person concerned. The information should be adequate, provided in a comprehensible form and should include modalities for withdrawal of consent. Consent may be withdrawn by the person concerned at any time and for any reason without any disadvantage or prejudice. Exceptions to this principle should be made only in accordance with ethical and legal standards adopted by States, consistent with the principles and provisions set out in this Declaration, in particular in Article 27, and international human rights law.
3. In appropriate cases of research carried out on a group of persons or a community, additional agreement of the legal representatives of the group or community concerned may be sought. In no case should a collective community agreement or the consent of a community leader or other authority substitute for an individual's informed consent.

In the video, Dr Farzan Hussein claims, in respect of these "vaccines", that she can "100% guarantee" (her words) "there is no negative effect on fertility". She further claims there is no evidence to the contrary at all.

In addition to the MHRA Yellow Card reports and the 917 unborn baby deaths referred to above, there is evidence of the adverse fertility affects of these medical experiments published in an academic journal.

The precautionary principle alone is sufficient reason to be circumspect and for Farzana to provide a “100% guarantee” is hubris/ignorance in the extreme. As a doctor, she should be well aware of the uncertainties relating to new, experimental medications.

This misleading lack of disclosure is in contravention of **Article 6** above and Enfield Council, its Councillors and Officers are complicit.

Growing evidence of abnormal blood clots among those injected with these experimental vaccines, sometimes leading to death, confirms their potentially lethal nature.

Anecdotal and statistical evidence continues to mount. For example, formerly healthy people including four British Airways and five Jet Blue pilots in the US died after receiving these experimental injections.
