## **Statement of facts:**

We attended Court on 24<sup>th</sup> June 2021 to answer the first summons issued on 27<sup>th</sup> April 2021. In the event, after waiting for two hours for the case to be heard, it was adjourned to 29<sup>th</sup> July 2021.

In the week ending 2nd July 2021, we received the summons dated 22<sup>nd</sup> June 2021, in respect of the current financial year. Enfield Council is applying for a Liability Order, with a hearing date of 22<sup>nd</sup> July 2021, for the full amount of Council Tax for 2021/22 plus costs.

The amount referred to in the Summons is £2,593.46 plus £75.50 (costs) making a total of £2,668.96.

When the second summons was issued, we had already paid £173.79 on 21<sup>st</sup> April 2021 being one third of the April and May monthly payments scheduled in Enfield Council Tax Bill 2021/22 dated 5<sup>th</sup> March 2021. See enclosed pages of the Bill schedule in question. We notified Nesil Caliskan, Mrs Y Brown and Geoff Waterton in my letter of the same date (21<sup>st</sup> April 2021, encl.) that we had paid this amount.

Subsequently, we paid one third of the instalments for June and July 2021 on 2<sup>nd</sup> July as marked on the reverse of the enclosed schedule referred to in the previous paragraph. Both amounts have cleared through my bank account.

Consequently, we've fulfilled our commitment to pay one third of Council Tax as referred to in our response to the first summons and our letter of 21<sup>st</sup> April 2021.

We've had no answer from Enfield Council, Councillors or Officers to the questions we've repeatedly raised with them other than the Summonses referred to in this response.

Our dispute with Enfield Council now spans two financial years 2020/21 and 2021/22.

### **Complaint:**

The amount of the Liability Order application doesn't reflect the amounts paid both before and after its issue.

The facility to pay monthly has again been arbitrarily withdrawn as it was for the previous financial year by notice from Enfield Council to which I responded in my letter of 1<sup>st</sup> October 2021.

We have incurred considerable costs in answering these summonses and in view of the Council's inability to communicate in any way to resolve this dispute, not only the Court's costs but ours are the Council's liability. Thus far, we have incurred at least 4 hours time cost at £108.00 per hour in dealing with this current Summons.

### Offer:

As Enfield Council have issued an erroneous application in respect of the amount of the Liability Order and that we are already in dispute in respect of the previous Council Tax year, we propose this matter be deferred until after the first summons is resolved.

If, however, Enfield Council wish to pursue this matter in Court on Thursday 22<sup>nd</sup> July 2021, we request that we can attend court to answer the Summons in respect of 2021/22.

Furthermore, we will apply to the Court for Enfield Council to cover our costs to date including attendance at Court. Thus far, our costs amount to £432.00 (4 hours) and we estimate at least another 2 hours to attend Court this coming Thursday, making a total of £648.00
